1. 3247 Viridian Point: New Construction Package submitted for Preliminary Approval:

Package submitted on February 22, 2022. The initial review noted several issues requiring modification and the need for two variances. The details have been documented and submitted to the owners and architect. Letter in file.

**Next Step:** Owner and architect to submit revised information and variance application forms for second ARC review.

2. 2330 Hill Circle: Landscape Remodel Package submitted for Approval:

Package submitted on February 27, 2022. The initial review found that this request is for the addition of a drainage rock bed that straddles the property line between the above and neighboring address.

By email to the submitting owner, the ARC has requested a second Landscape Application and Signed Landscape Drawing from the affected neighbor. Email letter in file

**Next Step:** The package is pending the receipt of the neighboring property owner's application and consent. Once received, files will be made for both project addresses and duplicate information will reside in both, for future reference. The ARC will do a second review after this information is received.
