## **Old Business:**

1. 3818 Glen Vista Point: New Construction Package submitted for Final Approval:

Final Design Package was received on March 8, 2022. After review, the ARC requested information on the facing materials that will be used on the planned retaining walls as well as the design and materials for the planned railing.

2. 2445 Lyons View: New Construction Package submitted for Preliminary Approval:

Requested plan revisions and additional information received on March 9, 2014. After review, the ARC requested clarification of the rear property set back line in relation to a rear patio and hot tub.

3. 3850 Hill Circle: New Construction Package (Revisions) submitted for Preliminary Approval:

Requested plan revisions and additional information received on March 14, 2022.

1. 3730 Camel Grove: New Construction Package submitted for Preliminary Approval:

Preliminary Design Package was received on February 28, 2022. After review, the ARC requested revisions to the documents to include: additional set-back lines for dwelling vs. garage; clarification on the design of a rear sunken patio; resolution of encroachment issues; additional information on proposed Dog Run.
