### Review & approve minutes of February 22, 2022

A motion was made to approve the minutes of February 22, 2022, as Submitted. (Holdridge/Entwistle) Motion passed. The minutes from March 17, 2022, will be compiled by Sheridan Rohde and emailed to committee members for approval.

## Committee Updates -

- 1. Committee Updates
  - a. Timberline and Hampson will complete a Spring Drive on Monday to go over maintenance on plant materials that they will be responsible for
  - b. Holdridge met with Susan Hunt, Copper Trowel regarding the annual flowers. Brad entertained a motion to approve the budget for flowers at the Fairways sign, in the six beds on Hill Circle, North and East gates, and Camel Pointe for \$16,555. (Entwistle/Harvey) Motion passed.
- 2. Community Manager Report
  - a. Nothing of significance
- 3. Updates Ongoing Projects
  - a. Tree Proposals
    - Requested a proposal from Tall Timbers and Timberline for an Austrian Pine off Grand Market and Hill Circle

- A motion was made to accept the Timberline bid for two Austrian Pines for \$2,100 (Harvey/Entwistle). Motion carried.
- Discussion ensued around the supplemental watering proposal from Timberline. Taylor Matthews clarified that the supplemental watering included the 6 Autumn Blaze maples on GMP, the 6 beds on Hill Circle, the two new Austrian pines (approved earlier in the meeting), and the two small trees at Phil's Bench. Taylor and/or Pam will provide an updated proposal after the spring drive on Monday, March 21<sup>st</sup>. A motion was made to accept the summer supplemental watering proposal from Timberline for \$2,100 (Harvey/ Entwistle) Motion carried.
- c. Tree Healthcare: Deep Root Fertilization from Tall Timbers; Hampson recommended that the Committee submit this to the Board for approval. A motion was made to approve the Tree Health Care program to the EB(Harvey/Holdridge). Motion Passed.
- d. Trail Connection RR1 Having troubles getting labor to complete the work, , Timberline passed on the bid
- e. Budget Requests: The Chair appointed Hampson to oversee this first and have Holdridge review it.

#### 4. Other Business

a. A resident approached a committee member regarding a KCPOA Dog Park. The committee had a lengthy discussion about this topic. The Chair noted that this should be brought up as a question for a future survey in the community.
