#### 4. 3150 Rockbrook Lane - Tree Trunk Removal vs. Carving

At the October 14, 2025 meeting, the ARC determined that it would allow an extension on carving the tree trunk under conditions that the trunk would be reduced in size to 5' now and a letter from the sculptor would be submitted indicating they were contracted to do the project in Spring 2026. A letter was sent to the owner advising same. This was followed by a second letter requesting their response. To date, no response received. Discuss next steps.

#### 5. 3755 Hill Circle - New Construction, Project Update

At the October 14, 2025 meeting, the ARC extended the "estimated completion date" for this new construction project with the request that monthly updates be provided by the owner/builder regarding activities and status. The first report was submitted on November 1, 2025 and circulated to the committee for review prior to this meeting.

## Ratification of Consent for Actions taken by the ARC between Formal Meetings:

#### 1. 5128 Lyda Lane - Structural Remodel, Preliminary Approval

This Structural Remodel project was resubmitted for a second Preliminary Approval on October 16, 2025 (prior approval had expired in January 2025). This project adds a dining room and additional patio space to the existing property. On October 20, 2025, the motion was made and seconded (Van Vurst/Danner) to grant Prelimianry Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file. Construction may not commence until the Final Package has been submitted and approved.

#### 2. 3425 Crest Hollow View - NC Landscape, Final Approval

The new construction Landscape Package was submitted on October 17, 2025 and circulated to the committee for review. It was noted that the A/C unit screening was not shown on the landscape plan and a revised plan was requested. The revised plan was submitted on October 21, 2025. Following a second review, the motion was made and seconded (Van Vurst/Danner) to grant Final Approval to this project. Motion carried. The developer was notified by email/USPS. Letter to file.

## 3. 1145 Almagre Heights - NC Landscape, Final Approval

The new construction Landscape Package was submitted on October 17, 2025 and circulated to the committee for review. It was noted that the A/C unit screening was not shown on the landscape plan and a revised plan was requested. The revised plan was submitted on October 21, 2025. Following a second review, the motion was made and seconded (Van Vurst/Danner) to grant Final Approval to this project. Motion carried. The developer was notified by email/USPS. Letter to file.

#### 4. 3660 Camels View - Landscape Remodel Change Request, Final Approval

A Change Request was submitted for a Landscape Remodel project originally approved on August 2, 2025. The request seeks approval for an additional privacy wall segment at a hot tub location. Following review, on October 23, 2025 the motion was made and seconded (Van Vurst/D'Amico) to grant Final Approval for this project addition. Motion carried. The owner was notified by email/USPS. Letter to file.

#### 5. 3925 Lumina View - Exterior Remodel, Final Approval

This Exterior Remodel project was submitted on October 21, 2025 and circulated to the committee for review. This project adds retaining walls and pathway with steps to the east side of the property for terracing purposes. Clarification and requested and received on October 23, 2025. On October 25, 2025, the motion was made and seconded (Van Vurst/D'Amico) to grant Final Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file.

#### 6. 3425 Hill Circle - Landscape Remodel, Final Approval

The Landscape Remodel Package was submitted on October 31, 2025 and circulated to the committee for review. This project adds a paver patio at the rear of the property. On November 2, 2025, the motion was made and seconded (Danner/Myers-Murty) to grant Final Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file.

#### 7. 3655 Camels View - Exterior Remodel, Final Approval

This Exterior Remodel project was submitted on November 3, 2025 and circulated to the committee for review. This project replaces the existing front door of the residence. On November 4, 2025, the motion was made and seconded (Van Vurst/D'Amico) to grant Final Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file.

## 8. 1855 Coyote Point - Exterior Remodel, Final Approval

This Exterior Remodel project was submitted on November 3, 2025 and circulated to the committee for review. This project replaces existing exterior siding with new stucco material. On November 4, 2025, the motion was made and seconded (Gathen/Danner) to grant Final Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file.

## 9. 3236 Virga Loop - Exterior Remodel, Final Approval

This Exterior Remodel project was submitted on November 4, 2025 and circulated to the committee for review. This project adds Jellyfish lighting to the residential structure. On November 6, 2025, the motion was made and seconded (Van Vurst/Gathen) to grant Final Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file.

## 10.1980 Inwood Circle - Structural Remodel, Preliminary Approval

This Structural Remodel project was submitted for Preliminary Approval on November 3, 2025 and circulated to the committee for review. This project adds a workshop room to the existing property. On November 7, 2025, the motion was made and seconded (Danner/Van Vurst) to grant Prelimianry Approval to the project. Motion carried. The owner was notified by email/USPS. Letter to file. Construction may not commence until the Final Package has been submitted and approved.
